We are pleased to report that the **online application system** continues to function efficiently and has been well received by most applicants. However, a few students, especially those from **remote villages**, still face certain challenges. These difficulties often arise due to **limited exposure to digital technology, low levels of parental education, and a preference for vernacular communication**. The League remains committed to assisting such students by providing personalized guidance and support to ensure that their applications are completed and submitted successfully, along with all required documents.

It has been observed that the **decline in the number of college-level applicants** is largely due to the **sharp rise in tuition fees and the overall cost of education**. Recognizing this, the League is taking proactive measures to **enhance the per capita scholarship amount** for college and professional courses.

We earnestly **appeal to our valued donors** to extend their continued support in helping us reach more deserving students and enable them to pursue their educational aspirations.

The League continues to **manage its funds prudently**, investing primarily in **Government Securities** to ensure the **safety of capital** while securing **steady and higher returns** for the sustainability of its welfare activities.

Foreign Education Loan

The League regrets to note that the response to the *Foreign Education Loan Scheme* has been relatively lower this year compared to previous years. This could be attributed to the steep rise in the overall cost of overseas education. Nevertheless, the League's management is taking active steps to promote the scheme and encourage more eligible students to benefit from it.

Recipients of this loan are expected to repay the amount, along with a nominal rate of interest, at the earliest possible opportunity. This timely repayment enables the League to recycle the funds and extend similar support to other deserving students aspiring for higher education abroad.

Recognizing the time needed to complete studies and secure suitable employment overseas, the League offers a moratorium of two years—or until the completion of the course—whichever is earlier. This considerate provision reflects our continued commitment to supporting students during their crucial academic years.

We express our sincere gratitude to all donors whose contributions sustain this meaningful initiative. We also earnestly appeal to members and well-wishers to continue their generous support for this dedicated *Foreign Education Loan Fund*, thereby helping many more students fulfil their dreams of global education.





Shri. Shevagoor Pundalik Kamath – From Beneficiary to Pillar of Support








Annual Endowments and Year-end Corpus (₹ Lakhs), 10 years: 2015-16 to 2024-25




Disbursements, 10 years: 2015-16 to 2024-25




Distribution of scholarships by academic segments, 2024-25 (₹ lakhs)




Number of students assisted by academic segments, 5 years: 2020-21 to 2024-25

THE G.S.B. Scholarship League Donation Options

(A) CORPUS DONATION:

1. **Patronship:** This is a life membership of the League with one-time fee of Rs. 1000/-

2. Contribute to the Foreign Education Loan Fund

This fund supports students pursuing university postgraduate studies abroad by offering repayable loans.

Loan terms: Understanding the time required to complete studies and secure employment abroad, the League offers an interest free moratorium of two-year or until the course completion as a gesture of support to students.

Contribution: ₹ 50,000 (or multiples thereof).

Purpose: Helps students bridge the financial gap for international education, especially in high-cost programs.

3(a) Establish a New Free Scholarship Endowment (FSE)

Creating a new endowment allows donors to leave a lasting legacy in their own name or in honor of a loved one. These endowments form part of the League's permanent corpus, and the income generated from them is used to support students annually.

Minimum amount: ₹ 5,000

Impact: Long-term support for education, with the donor's name associated with the scholarship.

3(b) Add to an Existing Free Scholarship Endowment (FSE)

Donors or Family members who have already established an endowment can increase its value by contributing additional funds.

Flexibility: Contributions can be of any amount and made at any time.

Benefit: Enhances the income-generating capacity of the endowment, enabling higher amount of scholarship disbursement, benefitting more and more students.

(B) NON-CORPUS DONATION:

1. Support a Student Scheme

Donors can choose to sponsor the education of a student identified by the League for a particular course.

Scope: Covers educational costs for graduate or professional courses. Total payment must be made upfront.

Process: The League selects eligible students based on merit and need.

Engagement: The league strives to connect Donors with students, establishing a personal connection.

Donation Options#: 1) 3-Year Graduate Degree Courses: ₹ 25,000 per year (Total ₹ 75,000)

2) 4-Year Professional Graduate Degree Courses: ₹ 25,000 per year (Total ₹ 1,00,000)

#Note: These options vary from time to time. Donor should therefore get in touch with the League Management for schemes prevalent on the date of the Donor's intended donation.

2. Make a General Donation

This is a one-time donation that is used to support the needy students in the current financial year.

Use: Disbursement to students in the same year.

Ideal for: Donors who prefer short-term engagement or want to contribute quickly.
